- I. **Welcome and Introductions** – Mark Lowis called the meeting to order and introductions were made.

- III. **Administrative Updates** – Mark Lowis mentioned the Charter for PISC is located on the IMP website. The Charter was developed back in 2004 and may need to be reviewed and updated. - V. **Presentations**
 - a. **Wrap Around** – Justin Tate did a PowerPoint presentation on Wraparound in Michigan. He went over planning strategies, underlying needs, the history and wraparound in Michigan. Handouts were provided.
 - b. **STR Grant** – Brittany Leek & Angie Smith Butterwick did a PowerPoint presentation titled MDHHS BHDDA/OROSC Response to the Opioid Crisis. Handouts were provided. Brittany talked about the Opioid STR Grant: overview; prevention initiatives; and treatment initiatives
 - c. **Fetal Alcohol Syndrome Disorder** – Cathy Fitzpatrick spoke about the 3 pilots for FASD

 - a. **Assertive Community Treatment** – Alyson Rush gave a MiFAST activity update. Handouts were provided. ACT/IDDT and ACT team scheduling and planning is in process. Eleven MiFAST visits with ACT teams are in various stages.
 - b. **Family Psycho-Education** – Alyson mentioned the FPE Steering Committee meetings are held on a quarterly basis. She spoke about the FY18 plans for FPE. Handouts were provided.

- e. Behavior Supports Committee – Price Pullins mentioned the 1st training for MiFAST reviews was completed. The first review for CMHSPs is coming up shortly.
- f. Co-occurring Mental Health and Substance Abuse Treatment – Jennifer Harrison was not in attendance.
 - a. IDDT - Data from 2017 MiFAST reviews is being aggregated for directing improvements and focus for site visits.

 - d. Co-occurring College – will be a two-day conference with more focus on specific co-occurring principles. All courses will have learning objectives and course-work to demonstrate learning.
 - e. COD MAT – Lisa Miller gave an update on the COD MAT expansion. Mark and Lisa described successes for improving the strength-based approach to OTP treatment.
