Upcoming Trainings

Michelle went through the upcoming trainings with the committee.

- Trauma Summit (2-day), December 7 8, 2023, in Lansing.

- IDDT 101 & 201 training will be offered for the second quarter of FY24.
 - IDDT 101, tentatively, January 18, 2023, February (date not secured yet), and March 13 or 14, 2024, depending on the availability of the trainer.
 - o IDDT 201, January 25, 2024, February 3 or 4, 2024, and March 21, 2024.
 - After these are offered the department is looking at having the trainings once or every other month depending on attendance levels.

 - This will be great for teams to network.
 - It will be with an aspect of trauma.

 - Transportation.
 - Name of the group and stigma attached to it.
 - How is it marketed?
 - Peer Recovery Coaches.
 - No pressure to be drug free in order to attend.
 - What kind of group would be more beneficial?
 - Maybe a combination of different things?
 - Money for snacks or food always makes individuals more comfortable.
 - The facilitator's confidence and skill level make a huge difference.
 - Didactic and skill based
- Benefits of doing groups for clinicians especially with high caseloads.
